d) ime ponuđača čije su ponude odbijene i razlog za odbijanje (neprihvatljiva ili ne ispunjava sve kvalifikacijske kriterije): After detailed examination of the bids the Evaluating Committee suggested to reject the bid for:

- LOT 2 JV Geodet d.o.o. Sarajevo - Angermeier d.o.o. Sarajevo

Reason for rejection is that the prices are substantially higher than the updated cost estimate and our available budget, and analysis of the Evaluation Committee is that the offered prices for most items significantly deviate from the market prices.

Procurement regulations in article 5.58 in paragraph c stipulates rejection of all bids/proposals if the Bids/proposals prices are substantially higher than the updated cost estimate or available budget. Also, Procurement regulations in article 5.59 in paragraph c stipulates that process may be considered valid if: "c. prices are reasonable in comparison to market values", which is not the case in this matter as we stated above.

Therefore, and after consultations with the procurement team of World Bank, bid evaluation commission propose to reject bid for LOT 2.
