## THE THIRTY-SIXTH SESSION OF THE SDI FBiH COUNCIL WAS HELD

The thirty-sixth session of the Spatial Data of the Federation of BiH Council (SDI FBiH Council) was held in the premises of the Federal Administration for Geodetic and Property Affairs on June 26, 2023. The members of the Council participated in the session in accordance with the Decision of the Government of the Federation of BiH.

At the session, the Council have discussed:

- 7. Adoption of the draft Instructions for data entry in SDI registers;
- 8. Adoption of the draft specification and metadata profile of SDI Federation BiH;
- 9. Adoption of the draft Instructions for documenting metadata of SDI Federation BiH;
- 10. Adoption of the draft document "Action Plan of SDI Federation BiH for 2023 2027";
- 11. Other.

The Federal Administration for Geodetic and Property Affairs, as the Coordinating Body of the SDI FBiH, has prepared and delivered to the members of the Council information on the implemented activities from the Work Plan for the establishment, maintenance and development of the SDI FBiH for the Year 2023.

The Working Group for Legal and Institutional Issues and the Working Group for Technical Standards have developed implementing rules for data entry in the SDI registers and for metadata of SDI Federation BH. At the 36<sup>th</sup> session of the SDI FBiH Council, drafts of implementing rules defining the technical conditions for interoperability, harmonization and sharing of spatial data sources were adopted. The same rules will go through a public consultation procedure and be prepared for the further prescribed procedure of obtaining the necessary opinions from the competent authorities after the adoption of the SDI FBiH Council.
